Parte B. RESUMEN LIBRE DEL CURRÍCULUM (máximo 3500 caracteres, incluyendo espacios en blanco)

Filósofo de la ciencia, especialista en filosofía de las ciencias sociales (en particular, la economía) y la medicina (el diseño de ensayos clínicos). He tratado de mostrar de qué modo el uso de técnicas estadísticas permite el consenso entre científicos y ciudadanos sobre políticas públicas. Soy autor y evaluador en las principales revistas internacionales de mi especialidad, así como de capítulos y entradas en obras de referencia internacional. He sido editor asociado de algunas de ellas: *European Journal for Philosophy of Science, History and Philosophy of the Life Sciences*, y *Theoria*. En esta última dirigí su incorporación al Open Journal System en 2009. Soy *Co-Editor in chief* de *BSPS Open*, la colección de monografías en acceso abierto de la *British Society for Philosophy of Science*. He participado en órganos de dirección de las principales sociedades académicas internacionales de mi especialidad y en 2017 he sido co-presidente del comité científico del mayor congreso europeo de filosofía de la ciencia, EPSA17 (también el más competitivo: 33% aceptación). He tenido contratos como profesor en 1 universidad extranjera (Sorbonne Université, catedrático) y 4 universidades españolas, y como profesor invitado en 4 universidades extranjeras.
